• Matters Arising:

Caravan (Leanda): Committee meeting in the coming weeks to narrow down choices of charities and date to schedule in January.

b) Reimagining: Bringing People Together:

Blue Christmas service scheduled for December 6th @ 5:00pm
 Lessons and Carol Service scheduled for December 18th at 10:00am

d) Nominations for Advisory Board and Wardens (Ed):

5. REPORTS & DISCUSSION

a) Churchwardens (Ed):

 Finances: Net gain of approximately \$25,000 realized for the 9-month period ending September 2022. Representing an overall favourable gain of \$19,000 over budget.

- **Special Vestry Meetings:** Scheduled for Sunday October 16th to elect Cathy Walker-Pilgrim as the new Envelope Secretary and October 30th for the Endowment fund.
- **Outreach Committee:** Meeting required to determine what funds are available to distribute to other organizations.
- **Blue Christmas Service:** Preparing invitation cards for distribution within the community.
- Parish Nurse: Position remains vacant, and search is ongoing.

b) Incumbent (Canon Barb):

- New contract signed. Will be staying on until new incumbent arrives. Working reduced hours. Met with the bishop who has agreed to provide some assistance for the 8:00am service.
- Focusing on return to pastoral care.
- Parish Selection Committee has been asked to change the goal of the Sunday Prayer to reflect more about finding the correct individual to lead the parish.

c) Committees & Ministry Areas:

- ACW (Ruth): Church Calendars will be available for sale at the 10:00am service.
- **Synod (Canon Barb):** To be held in November and will be attended by Canon Barb, Jewell Coy and Cathy Walker-Pilgrim.

6. OTHER BUSINESS

Code of Conduct Feedback:

• Dianne Rimmer and Gloria Downey joined the meeting to provide feedback on the Code of Conduct shared with the Parish in Trinity Today. Request that the Wardens arrange a Town Hall to give parishioners an opportunity to voice their concerns and not wait for the Vestry meeting. Dianne and Gloria to share their written feedback with the Wardens to be included in the Agenda for the November Advisory Board meeting. Nancy encouraged Advisory Board members to take the opportunity to reach out to parishioners to get a sense of how others are feeling about it.

Correspondence Regarding Code of Conduct

Email Received from Eric Preston on Monday October 31, 2022

As someone who had input to the development of the Code I strongly support the need for a Code and consider this current version to be very good as our starting point. It's important to have a written document to define our expectations about behaviour. What some people might see as being simply assertive could be viewed by others as harassment, so we need to be specific about definitions. It also provides a common reference point if anyone is concerned about certain behaviours or is uncertain as to what their rights and obligations are.

One thing our Code doesn't contain is a statement about inappropriate use of the Code and the filing of malicious complaints. If people are concerned about this, we could include a statement that a malicious complaint is considered a breach of the Code.

Correspondence Regarding October Advisory Board Meeting Attendance and Minutes

The following paragraph contains my 2 or 3 sentences that I give permission to be included in the minutes of the October 18th, 2022 Advisory Board Meeting under the agenda item "Other Business" and labelled Trinity TODAY. I am highlighting said words so that there is no misunderstanding as to what can be included in the minutes of the October 18th, 2022 Advisory Board Meeting. They are not a summary but only refer to what I spoke about.

Gloria Downey expressed her concerns about the content of the last 6 pages of the September 22, 2022, 10 page newsletter Trinity TODAY. This 1st edition of Trinity TODAY was sent out to all parishioners of HTC. The 6 pages laid out a Code of Conduct for HTC.
