4. ITEMS FOR DISCUSSION

a) Motion from the diocese for social justice approved at vestry.

The exact motion approved by HTC needs to be forwarded to the diocese:

We, the Parish of Holy Trinity Thornhill, call on the Province to double social assistance rates for both Ontario Works and the Ontario Disability Support Program, and thereafter to index these rates to inflation, so as to provide a safety net that enables people to meet their most basic needs.

To demonstrate our commitment to this motion, we commit to:

- 1. a letter- writing campaign as voters and Christians to our elected officials at the municipal, provincial and federal levels, urging them to actively work with the Government of Ontario to implement these social assistance rates
- 2. continue our support of individuals in our local area with very basic needs through Out of the Cold, Christmas Assistance and other outreach programs.

Linda Robertson and Rebecca Jones will draft one or two sample letters to initiate our letter-writing campaign, and will provide parishioners with the politician's addresses

5. REPORTS & DISCUSSION

- a) Incumbent's Report: Canon Barb
 - a. Parish Picnic scheduled for June 4, 2023
- b) Brother Reg:
 - a. He is leading work on Christian Formation for Youth and Children with Hazel, Cassandra, Leanda and Rebecca. They are looking at two programs:
 - Godly Play (a Montessori-based structured program), and
 - Journey to Adulthood (adolescents 18 year olds)

They will be attending training in June; hopefully looking at the fall to initiate these programs.

- c) Warden's Report: Robin (see attached)
 - a. Question about the counters: Ed Carter is working with Miriam Irving to determine the most effective way to manage the donations and the work of the counters.

- d) Committees & Ministry Areas: ACW
 - a. Saturday April 29, 1:30 4:00 a social event for all diocese ACW will be held at HTC.

6. OTHER BUSINESS

- a) Rummage Sale:
 - a. We had hoped to have a sale in the spring 2023, both to raise funds for outreach and to service those in low-income brackets who rely on the rummage sale. Nancy has the binder of instructions prepared by Bari-Lynne Butters. The ACW asked the Adv Board to be responsible for the sale and put forth these recommendations:
 - i. Start small with clothing only
 - ii. Do this latter in the spring
 - iii. Saturday May 13, 2023?
 - b. The Adv Board needs to look at who will organize it, and how to manage the physical labour involved. Leanda and Bonnie will look at securing a class at HTS to help with the labour.
 - c. The Wardens will look into whether or not the sale is possible, and who will lead it.
 - b) For April Meeting: Marketing discussion to be led by Cassandra

Warden's Report: REPORT OF THE MEETING OF THE CORPORATION March 14, 2023

- a. This was the first meeting of the Corporation since the Vestry meeting of February 26, as a result much of the time was spent on bringing new members up to speed on current issues and dealing with some of the necessary housekeeping items. Some of these will be of interest to the Advisory Board:
 - >> Those in high-risk roles (Sunday school teachers, wardens, treasurer, envelope secretary) must have a police record check (PRC) done. Laura, our Office Administrator will assist those needing a police check and co-ordinate those needing SMP training (see below)
 - >> All office-bearers, staff and volunteers must have Sexual Misconduct Policy (SMP) training
 - >> Elements of the Incumbent's Annual Return

- i. A Parish wide bulletin was sent informing them of the roles and responsibilities for the year.
- ii. One point to note is that this year we have Communication as a shared responsibility for all 4 Wardens.
- c. The financial statement for the period ending February 28, 2023 (attached) was reviewed and the following points were noted:
 - i. In February, we had a net Operating deficit of \$14K on an income of \$15K. The budgeted deficit was \$8K on an income of \$24 K and expenses of \$32K

- ii. Year to date, we have a deficit of \$18K on an income of \$37K. The budgeted deficit was \$20K on an income of \$47 and expenses of \$67
- iii. Envelope deposits are lower than budget as deposits were not made. We will be looking to establish a deposit schedule with the Counters.
- iv. Property income was lower as well for the same reasons
- v. Insurance payments will be adjusted for March now that the companies realize that HTC does direct Deposit
- vi. Delays in receiving invoices for snow removal resulted in the large payment in February
- d. We are planning that the Treasurer (Ed Carter) will provide a monthly financial statement with "NOTES" and will be invited to attend both the meetings of the Corporation and Advisory Board on a 1/4ly basis.
- e. Future Meetings of the Corporation will deal with more of the operational aspects of HTC, as the Wardens become familiar with their Portfolios.

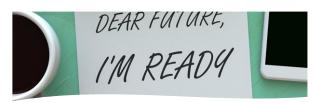

In March, we had a Net Operating deficit of \$9K on Income of \$50K and Expenses of \$59K. The budgeted gain was \$10K on income of \$46K and expenses of \$36K Year to date, we have a gain of \$17K on income of \$88K and expenses of \$71K. The budgeted deficit was \$9K on income of \$93K and expenses of \$102K Items of Interest:

 $Envelope\ Receipts\ (YTD)\ are\ \$2K\ lower\ than\ budget;\ We\ need\ to\ monitor\ future\ deposits\ as\ we\ have\ lost\ 4\ PAG\ so\ far\ this\ year.$

Q1 investment income was receided from the Diocese (Housing Income & Interest Income)

Insurance - Direct Deposit has commenced for insurance premiums until October

Office Income - March expenses include 2022 audit fee of \$11K. However the YTD number is adjusted due to the \$6K accrual in the 2022 financial statement Maintenance - Paid our first snow removal invoice for the winter in March - \$9300 and plumbing invoice \$1600

Salaries & Stipends -YTD amount is adjusted by the \$37K accrual in the 2022 financial statement

Other

Received letter from the Pension Office stating the missed premium amount will be \$55K split evenly between Jesus and HTC to cover the contributions missed 2012 - 2021
